5. COMPELLED DISCLOSURE

- 5.1 In addition to the purposes set out in the Policy, we may disclose any data we collected or processed from you if it is required:
 - 5.1.1 under applicable law or to respond to a legal process, such as a search warrant, court order, or subpoena;
 - 5.1.2 to protect our safety, your safety or the safety of others or in the legitimate interest of any party in the context of national security, law enforcement, litigation, criminal investigation or to prevent death or imminent bodily harm;
